Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security for the amount as specified in table below and valid for 30 days beyond bid validity period If bidder wishes to submit bid security in the form of cash, the cash should be deposited office bank account, Nepal Bank Limited Kushma, Parbat, Account No. **Ga-3-0-0660300000003000003 (DHARAUTI)** and Submit the receipt of the deposited amount of cash with the bid.
