Electronic Sealed Quotations will be opened in the presence of Supplier's representatives who choose to attend at 16th days from the date of publication of this notice on 14.00 hours at the office of **Kushma Municipality, Office of Municipal Executive, Kushma, Parbat, Gandaki Province, Nepal**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of as mentioned below, which shall be valid for 30 days beyond the validity period of the bid.
